Athletic Committee: Ann Byrd reports that registration for Baseball/Softball season has begun.

**Maintenance Supervisor:** Jim Smith reported that Maintenance has completed all the maintenance of the vehicles and equipment, Madison County Roofing has finished the roof, siding, and gutters on the Senior Building from the storm damage. **Office Manager**: Sandy Thompson reports that PEP grant money has come in we received \$84,913.00.
