AN ORDINANCE MAKING A TAX LEVY FOR THE TRI-TOWNSHIP
PARK DISTRICT IN THE COUNTY OF MADISON AND STATE
OF ILLINOIS FOR THE FISCAL YEAR BEGINNING
APRIL 1, 1980 AND ENDING MARCH 31, 1981

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF TRI-
TOWNSHIP PARK DISTRICT:

ARTICLE I. That this Ordinance be and the same is hereby
termed the Annual Tax Levy Ordinance for the Tri-Township Park
District in the County of Madison and State of Illinois.

ARTICLE II. That there be and hereby is levied and assessed
upon all the real and personal property situated within the
corporate limits of the Tri-Township Park District in the County
of Madison and State of Illinois, the sum of Twenty-Three Thousand
Dollars (\$23,000.00), which said amount shall be raised by taxation
upon all assessed property according to its value as the same is
equalized or assessed by the Department of Revenue and which said
amount is to defray the expenses of the Tri-Township Park District
as provided by the Annual Appropriation Ordinance beginning April 1,
1980 and ending March 31, 1981, as provided by Ordinance of said
Tri-Township Park District as passed and approved on the 19th day
of August, 1980, all of which was done by the Secretary of the
Tri-Township Park District, the said Tax Levy being in detail as
follows:

PARK DISTRICT BUDGET AND APPROPRIATION ORDINANCE FOR 1980-81

of the TRI-TOWNSHIP PARK DISTRICT in the County of Madison, State of Illinois, for the Fiscal Year beginning April 1, 1980 and ending March 31, 1981.

WHEREAS, all legal requirements have been complied with;

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Tri-Township Park District, Madison County, Illinois, in meeting assembled, as follows:

ARTICLE I

That the fiscal year of this Park District is hereby fixed and declared to be from April 1, 1980 to March 31, 1981.

ARTICLE II

That the following budget, containing a statement of the cash on hand at the beginning of the fiscal year, an estimate of the cash expected to be received during said fiscal year, an estimate of the expenditures contemplated for such fiscal year and a statement of the estimated cash expected to be on hand at the end of such fiscal year is hereby adopted as the budget of this Park District for the said fiscal year and shall be in full force and effect from and after said date.

ARTICLE IV

That all unexpended balances of any item or items of any general appropriation made in this Ordinance, be expended in making up any insufficiency in any other item or items in the same general appropriation for the same general purpose of any like appropriation made by this Ordinance.

ARTICLE V

That all unexpended balances from annual appropriation of previous years are hereby reappropriated.

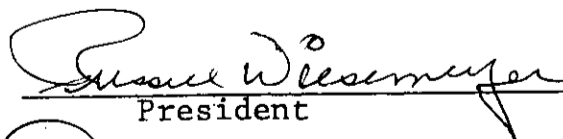
ARTICLE VI
